Special Meeting of By-Laws and Elections Subcommittee

March 30, 2015

There was a special meeting of the By-Laws and Elections subcommittee on Monday, March 30, 2015 at 4:00 p.m. The purpose of the meeting was to discuss a petition submitted to By-Laws by Dr. Hilary Earl and signed by 93 faculty to have Senate consider a return to a Universal Senate.

Dr. Tabachnik provided context and background to the petition. Some discussion was held regarding timelines should the matter to be brought to the April Senate as a Notice of Motion with a view to the possibility that a successful Senate vote at the May Senate could result in implementation by the first Senate of the 2015-16 academic year. It was noted that any such motion would require a two thirds majority of Senate.

Extensive discussion took place about the need to provide Senate with sufficient time, context and information to make an informed decision about the future structure of Senate. In light of the gravity of the issue By-Laws committed to providing Senate with a background report on the need for Senate Reform, including the possibility of a return to a universal senate. By-Laws will spend the spring/summer preparing this report with a view to consideration by Senate early in the 2015-16 academic year.

A question was raised about modifying academic calendar language to indicate students pursuing an Honours Specialization, Specialization, Major or Minor in Psychology at Nipissing can complete the degree requirements at both the North Bay and Muskoka campuses. After a lengthy discussion and referral to the NU IQAP procedures, it was suggested that the following should be undertaken by the Psychology Department:

- Try to locate documentation indicating Senate approval to offer the program at Muskoka
- If not approved/not found, prepare Stage I Letter of Intent for a Major Modification of the program and submit to PPC for approval and recommendation to Senate
