- (c) Terms of Reference:
  - (i) to call Senate meetings and prepare the agendas of Senate;
  - (ii) to approve Senate minutes for circulation prior to adoption;
  - (iii) to manage the workflow of Senate and its committee/subcommittees in order that business is carried out in an expeditious and timely fashion;
  - (iv) to ensure that Senate By-Laws are followed and that Senate decisions are properly recorded, transmitted and implemented;
  - (v) to consider, for approval and conveyance to Senate, reports and recommendations of the By-Laws & Elections Subcommittee and Honorary Degree Subcommittee;
  - (vi) when required, to exercise Senate's authority and act on Senate's behalf during the Senate summer recess period, with the understanding that all such actions shall be reported at the September meeting of Senate;
  - (vii) the Senate Executive may act on behalf of Senate when quorum of Senate cannot be established, or when the regularly scheduled Senate meeting is delayed, to deal with any urgent matter that is within the responsibility of Senate, with the understanding that all such actions will be reported at the next meeting of Senate;
  - (viii) to approve degree audits for all undergraduate students who have applied to graduate, and to recommend all candidates to Senate for the conferring of undergraduate degrees, diplomas and certificates;
  - (ix) meetings at which candidates for honorary degrees are discussed shall be conducted in camera and considered strictly confidential; and
  - (x) to deal with such other matters as may be assigned from time to time by Senate.

The Speaker provided a rationale as to why Motion 1 was back on the agenda. Due to an error in ruling, it was declared to be carried by a 13 to 12 vote, in favour. According to By-Laws the vote requires a 2/3<sup>rd</sup> majority.

Senator Burk brought forward the following motion:

There was a lengthy discussion that ensued regarding the validity of the motion being brought back. The Speaker advised that the vote was conducted properly but the decision of the vote was improperly represented.

The Chair noted that the Senate Executive Committee realized that something was done incorrectly. He also advised that once the minutes are approved, they stand as record. Therefore by bringing back the motion, there is a chance to revisit it before the minutes are approved. Procedurally it is the right thing to do.

  - AQAPC is responsible for reviewing and providing Senate the substantive outcomes of cyclical review of existing academic programs;
  - AQAPC is responsible for reporting to Senate recommendations resulting from program reviews.
- AQAPC discussed revisions to the course template with the inclusion of competencies, learning outcomes, expected resources, consultation with colleagues and Faculty Councils, resources, frequency of expected delivery in rotation with other courses, delivery (in class, blended, on-line, in-community, other), expected enrolment, learning environment and curriculum/syllabus. Other universities' processes will also be examined and the information will be shared with faculty so there is an alignment. The template will feed into Academic Planning and Quality Assurance and will also streamline the Senate process;
- AQAPC discussed how the Academic Plan, Quality Assurance and Budget should all connect so that information can be shared and the process does not have to be recreated every time. A draft Academic Plan template was forwarded to AQAPC members and it was asked that the template be shared and discussed with colleagues and written feedback. The Provost will work with the Associate Registrar, Curriculum and Advising to develop the new course template;
- The AQAPC reviewed and approved recommending to Senate the Stage 2, BSc Honours Specialization and Specialization in Data Science, and BA Honours Specialization and Specialization in Data Science.

# Admission Policy for Bachelor of Education Primary/Junior French as a Second Language stream

Primary/Junior teacher candidates who wish to enrol in the French as a second language stream must possess oral and written fluency in French and submit proof of at least **one** of the following credentials to the Office of the Registrar:

- a Certificate of Bilingualism from Nipissing University, Laurentian University or Level C from the Federal government completed within two years of application to the BEd program or
- a transcript showing proof of graduation from a francophone university having studied in the French language or
- a Level B2 Diploma (provided upon successful completion of the DELF French proficiency test) completed within two years of application to the BEd program or
- Three full undergraduate courses (6-one semester courses) in French with no more than one full course (2-one semester course) at the first-year level. It is recommended that students present a combination of French language, grammar, composition, literature and culture courses. No more than one full course (2-one semester courses) in translation may be counted.

#### Rationale:

This admission policy supports the new Primary/Junior French as a Second Language stream. This policy allows applicants from varying French backgrounds flexibility in showing their oral and written fluency in the language. This stream option will be available to both Concurrent Education and Consecutive Education applicants. Concurrent Education students will need to meet the above requirements by applicable deadlines in their fourth year of the program as per progression requirements.

# Bachelor of Education (BEd) Junior/Intermediate (JI) and Intermediate/Senior (IS) French as a Second Language Teachable Admission Policy Modification

**Motion:** That the Undergraduate Studies Committee recommend to Senate that the BEd JI and IS French as a Second Language teachable admission policy modification be approved.

# **Current Policy**

# Junior/Intermediate (JI)

Candidates must have at least three full undergraduate courses, or equivalent, in the teaching subject being applied to.

**French as a Second Language** – No more than one full course (2-one semester courses), or equivalent, can be at the first year level. Applicants must possess oral and written fluency in the French language and a thorough knowledge of grammar.

# **Intermediate/Senior (IS)**

Candidates must have at least five full undergraduate courses, or equivalent, in the first teaching subject being applied to and at least three full undergraduate courses, or equivalent, in the second teaching subject being applied to.

**French as a Second Language** – No more than two full courses (4-one semester courses), towards a first teaching subject in French can be at the first year level. No more than one full course (2-one semester courses) towards a second teaching subject in French can be at the first year level.

# **Proposed Change to Policy**

# Junior/Intermediate (JI)

Teacher candidates for French as a second language at the Junior Intermediate level must possess oral and written fluency and submit proof of at least one of the following credentials to the Office of the Registrar:

- a Certificate of Bilingualism from Nipissing University, Laurentian University or Level C from the Federal government completed within two years of application to the BEd program or
- a transcript showing proof of graduation from a francophone university having studied in the French language or
- a Level B2 Diploma (provided upon successful completion of the DELF French proficiency test) completed within two years of application to the BEd program or

• three full undergraduate courses (6-one semester courses) in French with no more than one full course (2-one semester courses) at the first-year level. It is recommended that students present a combination of French language, grammar, composition, literature and culture courses. No more than one full course (2-one semester courses) in translation may be counted towards the teaching subject.

# **Intermediate/Senior (IS)**

Teacher candidates for French as a second language at the Intermediate/Senior level must possess oral and written fluency and submit proof of at least one of the following credentials to the Office of the Registrar:

- a Certificate of Bilingualism from Nipissing University, Laurentian University or Level C from the Federal government completed within two years of application to the BEd program or
- a transcript showing proof of graduation from a francophone university having studied in the French language or
- a Level B2 Diploma (provided upon successful completion of the DELF French proficiency test) completed within two years of application to the BEd program or
- five full undergraduate courses (10-one semester courses) towards French as a second language as a first teaching subject with no more than two full courses (4-one semester courses) at the first year level or at least three full undergraduate courses (6-one semester courses) towards French as a second language as a second teaching subject, with no more than one full course (2-one semester courses) at the first year level. It is recommended that students present a combination of French language, grammar, composition, literature and culture courses. No more than one full course (2-one semester courses) in translation may be counted towards the teaching subject.

### Rationale

This policy modification allows applicants from varying French backgrounds flexibility in showing their oral and written fluency in the language. It also indicates more clearly, what the Schulich School of Education requires of their teacher education candidates. This will assist prospective students when preparing to apply to Nipissing. This modification is for both Concurrent Education students and Consecutive Education applicants. Concurrent Education students will need to meet the above requirements by applicable deadlines in their fourth year of the program as per progression requirements.

# Report of the By-Laws and Elections Subcommittee

August 21, 2018

There was a meeting of the By-Laws and Elections Subcommittee on May 15, 2018 at 10:30 a.m. in F307.

Present: B. Hatt, N. Colborne, D. Davis, D. Tabachnick

The Agenda of the May 15, 2018 By-Laws and Elections Subcommittee meeting was approved.

Moved by D. Tabachnick, seconded by N. Colborne that the Report of the April 24, 2018 By-Laws and Elections Subcommittee meeting be accepted.

**CARRIED** 

It was advised that the content of the Motion from Dr. Gillian McCann is under review.

A brief discussion took place regarding the Joint Governance Committee – Freedom of Expression. It was advised that this item is considered to be a most important matter but seemed to fit more with the Collective Agreement than with By-Laws and Elections. It was therefore referred to the Standing Joint Committee on Governance for review with appropriate recommendations coming to Senate, CA Bargaining Teams and the Board of Governors.

The following information was not received in time for inclusion in the April 13, 2018 Senate Agenda, and was forwarded out to Senators by e-mail at the meeting:

# Statement on the Importance of Collegial Governance at Nipissing

Collegiality is essential to the structure and practice of university governance. Given the diversity of its constituent groups and its mission of advancing truth and knowledge, the university is best served by the open expression of ideas and opinions; encouraging thoughtful dissenting views. Successful collegial governance depends on all participants acting in good faith and having access to relevant information to offer sound opinions. In the same spirit, decision-making must ensure inclusiveness, equality, transparency, and broad participation.

Recognizing the obligations, responsibilities and jurisdictions of the Senate and the Board of Governors, collegial governance requires interdependence, mutual respect and good relationships. The primary mission of the University is academic and is served by responsible resource allocation and planning.

All of us must do our part to uphold the ideals of academic freedom and democratic practice inherent in our system of collegial governance.

The alignment of Senate By-Laws and Senate membership regarding senior administrative hires was discussed. It was agreed that Senate By-Laws are silent on this issue and that this item should be sent to the Standing Joint Committee of the Board and Senate on Governance for discussion and recommendations to Senate and, if necessary, the Board.

The By-Laws and Elections Subcommittee discussed the merits of and agreed that a Senate Orientation for new and returning Senators be held in the Fall of 2018. The session could be held in conjunction with the Board for a Joint Board/Senate Orientation. Further discussion on this matter will take place with the Board Chair and the Board Secretary in mid to late August.

It was noted under Other Business that Article 9.1 be sent back to Senate for a ratifying vote at the May 25, 2018, Senate meeting. In the Senate meeting of May 11, 2018, the Motion to approve Motion 2 (an amended Article 9.1) was declared to have been carried. A vote count was called for and the Motion passed with a majority of one vote. Later, it was discovered that the Motion required a 2/3 majority vote of Senators because it represented a change to the By-Laws (Art. 7.3 (c) (iv)). It was decided by the By-Laws and Elections Subcommittee and subsequently the Senate Executive Committee, that the Motion be again presented to Senate at the May 25, 2018 Senate meeting for a proper vote in accordance with Article 7.3 (c) (iv).

The Motion will read:

That Senate approve Article 9.1 Senate Executive Committee be amended as outlined below:

- 9.1 Senate Executive Committee (EXEC)
  - (a) Ex Officio Members:
    - (i) the President, who shall be (Chair);
    - (ii) the PVPAR, or designate, who shall be (Vice-Chair);
    - (iii) the Academic-Deans, or their designates;

- (iv) the Speaker; and
- (v) the Deputy Speaker.
- (b) Members Elected by Faculty Council:
  - (i) one (1) tenured or tenure-track faculty Senator\*, from each faculty; and
  - (ii) one (1) student Senator from the NUSU Executive.
    \*tenured faculty preferred
- (c) Terms of Reference:
  - (i) to call Senate meetings and prepare the agendas of Senate;
  - (ii) to approve Senate minutes for circulation prior to adoption;
  - (iii) to manage the workflow of Senate and its committee/subcommittees in order that business is carried out in an expeditious and timely fashion;
  - (iv) to ensure that Senate By-Laws are followed and that Senate decisions are properly recorded, transmitted and implemented;
  - (v) to consider, for approval and conveyance to Senate, reports and recommendations of the By-Laws & Elections Subcommittee and Honorary Degree Subcommittee;
  - (vi) when required to exercise Senate's authority and act on Senate's behalf during the Senate summer recess period, with the understanding that all such actions shall be reported at the September meeting of Senate;
  - (vii) the Senate Executive may act on behalf of Senate when quorum of Senate cannot be established, or when the regularly scheduled Senate meeting is delayed, to deal with any urgent matter that is within the responsibility of Senate, with the understanding that all such actions will be reported at the next meeting of Senate;
  - (viii) to approve degree audits for all undergraduate students who have applied to graduate, and to recommend all candidates to Senate for the conferring of undergraduate degrees, diplomas and certificates;
  - (ix) meetings at which candidates for honorary degrees are discussed shall be conducted *in camera* and considered strictly confidential; and
  - (x) to deal with such other matters as may be assigned from time to time by Senate.

Some of the substantive changes to the Senate By-Laws that were recommended to Senate in the 2017-18 academic year included the following:

- the Graduate Studies Council become a Graduate Studies Standing Committee of Senate with two Subcommittees (Graduate Standing & Petitions and Graduate Studies Leave & Time Extensions);
- Membership, ex-officio membership and terms of reference were revised;
- Suggested revisions for the capacity of the Senate Executive to act on behalf of Senate under certain conditions. (This item was discussed at length by the By-Laws and Elections Subcommittee and the Senate Executive Committee. The amendment was referred back to the Senate By-Laws to specifically examine quorum and to consider modifying the amendment to include faculty representation as a requirement for quorum.);
- Clarification and consistency of language and position titles.
- Membership and terms of reference were approved with amendment;
- By-Laws were amended to include the membership and terms of reference of the Standing Joint Committee of the Board and Senate on Governance and the Senate Budget Advisory Committee;
- To ensure proportional representation on Senate an up-to-date faculty count with the following breakdown was provided: APS = 8 Senate Reps., A&S = 17 Senate Reps., SSoE = 11 Senate Reps, FT CASBU = 2 Senate Reps. The total number of Senators for the 2018-19 Academic year will be 38.
- Following a review of the membership of faculty Senators and non-Senators on Senate committees and subcommittees it was found that stronger faculty Senate representation is required, with a goal towards having a ratio of 2 Senators to 1 non-Senator on Senate committees and subcommittees;
- The creation of a faculty award that recognizes service was suggested and the Chancellor's Award for Excellence in Service was created for implementation in 2018-19;
- The Annual Senate election procedures and timelines, Article 4.3, were discussed and it was suggested that the deadline for elections be moved back by one month so that the process can be completed by 01 April;
- To better reflect the terms of reference, the Planning and Priorities Committee (PPC) was renamed the Academic Quality Assurance and Planning Committee (AQAPC). Changes to the terms of reference were also made;
- The Policy on Posthumous Undergraduate Degrees/Certificates of Academic Achievement was renamed the Policy on Posthumous and In Memoriam Degrees;
- A joint letter from the Senate Chair and the Speaker was sent to the Deans outlining Senate duties and responsibilities. Personalized letters will be sent to each new faculty and student Senator advising of them of the Senate committees and subcommittees;
- A motion was approved to reorder the Senate agenda to place "Reports From Other Bodies" ahead of "Question Period";
- A recommendation was made that a Senate Orientation, in conjunction with the Board of Governors, for new and returning Senators be held in the fall of 2018.

A number of changes to the bylaws were housekeeping items, mostly related to position title changes. All requests were accompanied by a rationale.
