#### **Admissions**

Admission to the Bachelor of Science in Nursing Scholar Practitioner Program (SPP) is limited. Admission consideration is based on the following criteria:

- A recognized undergraduate degree with a minimum overall average of 75% (calculated on the best 10 full course equivalents not including transfer courses out of the first 25 full course equivalents completed). Applicants with final degrees containing less than 10 full course equivalents will not be considered.
- Successful completion of one (1) course in anatomy and physiology and one (1) course in general psychology at the university level from a recognized institution. Transcripts submitted at time of application must show either all courses required for admission consideration either completed or in progress. This includes the prerequisite courses of anatomy and physiology and general psychology. If these courses are in progress a transcript must be submitted by the document deadline indicating that you are registered for the course. Applicants who have completed courses not listed and wish to have them evaluated for equivalency should contact the Admissions Office at admissions@nipissingu.ca. We recommend that prospective applicants send their request prior to submitting an application.

Applicants must hold a recognized undergraduate degree, have completed all prerequisite courses and be able to provide a final transcript indicating that the degree has been conferred by **June 30, 2020** in order to be eligible to apply. The degree must be conferred no later than **Spring 2020** Convocation.

#### **Transcripts**

Official transcripts are required from all post-secondary institutions (college and university) attended, including transcripts from institutions attended on exchange and Letter of Permission (even if courses are incomplete and grades do not appear on the transcript). Transcripts submitted at time of application must show all courses required for admission consideration either completed or in progress. All transcripts must be received by **4:30 pm ET** on **February 6, 2020**.

Nipissing University transcripts need not be submitted, however, if you attended Nipissing University prior to 1992 you are considered a Laurentian University student and you must submit that transcript. If you have completed courses outside of North America you must have all your foreign transcripts evaluated and translated by World Education Services (WES): www.wes.org/ca. A WES Credential Evaluation Report, including a Course-By-Course Analysis, must be sent directly to Nipissing University by **4:30 pm ET** on **February 6, 2020**. Applicants are responsible for the costs associated with the WES evaluation and any translation required. Note that it can take upwards of six weeks for WES to receive official transcripts from a foreign academic institution, after which point the WES evaluation can take a week or longer to complete. Applicants should begin the evaluation process as early as possible.

# **English Language Proficiency**

Applicants whose first language is not English may be required to supply proof of proficiency in English. Among other options, acceptable proof of English proficiency includes the Test of English as a Foreign Language (TOEFL), International English Language Test Service (IELTS), or the Pearson Test of English (PTE) Academic. #### **CASPer™** Assessment

All applicants are required to complete the online CASPer<sup>™</sup> (Computer-Based Assessment for Sampling Personal Characteristics) assessment. CASPer<sup>™</sup> is an online test which assesses for non-cognitive skills and interpersonal characteristics that Nipissing believes are important for successful students and graduates of the Scholar Practitioner program.

In order to take CASPer<sup>TM</sup>, applicants will be responsible for securing access to a computer with audio capabilities, a webcam, and a reliable internet connection on the selected test date. CASPer<sup>TM</sup> can be taken practically anywhere that you can satisfy the aforementioned requirements. No exceptions will be provided for applicants unable to take CASPer<sup>TM</sup> online due to being located at sites where internet is not dependable due to technical or political factors.

To schedule your CASPer<sup>TM</sup> test, visit <a href="www.takeCASPer.com">www.takeCASPer.com</a> and register using your OUAC Reference number. You will be provided with a limited number of testing dates and times. Please note that these are the only testing dates available for your CASPer<sup>TM</sup> test. There will be no additional tests scheduled. Please use an email address that you check regularly; there may be updates to the test schedule. <a href="web">We do</a> not require you to have written the test by the application/document deadline. You can choose to write on any of the available test dates. Please direct any inquiries about the test to <a href="support@takecasper.com">support@takecasper.com</a>. The CASPer<sup>TM</sup> test is comprised of 12 sections of video-based or word-based scenarios. Following each scenario, you will be required to answer a set of 3 probing questions under a time limit. No studying is required for CASPer<sup>TM</sup>, although you may want to familiarize yourself with the test structure at <a href="takeCASPer.com">takeCASPer.com</a>, and ensure you have a quiet environment to take the test.

#### **Personal Statement**

All applicants will prepare a Personal Statement. The Personal Statement will be a response to the following question:

Considering your past educational background and experiences, please outline why you consider yourself a strong candidate for this program?

The Personal Statement should be no more than two (2) single pages double spaced (12pt, Arial). You are required to submit three (3) copies. Please ensure that your name is included on your Personal Statement.

Applicants who meet the minimum academic admission requirements will have their Personal Statement and Reference Letter reviewed by the Scholar Practitioner Program Admissions Committee.

#### **Reference Letter**

All applicants will submit one (1) academic or professional reference letter. You are required to submit three (3) copies of the reference letter. The letters should be in a sealed envelope with the referee's signature over the seal.

The letter should address the following:

How long have you known the applicant?

In what capacity have you known the applicant?

Indicate your assessment of the applicant in the following areas:

- Academic and/or professional preparation in social sciences
- Evidence of scholarly/professional research
- Quality of clinical or practice skills
- Quality of scholarly/professional writing
- Ability to be self-directed
- Openness to feedback and personal/professional reflection
- Ability in theoretical/conceptual thinking
- Computer literacy

Provide a candid assessment of this individual's potential for success in completing the program including a description of specific activities or accomplishments that reflect the applicant's strengths and opportunities for development.

Provide contact information, should the selection committee need any further information.

Applicants who meet the minimum academic admission will have their Personal Statement and Reference Letter reviewed by the Scholar Practitioner Program Admissions Committee.

#### Interview Information

All applicants who meet the minimum academic admission requirements and the minimum required scores on the Personal Statement and Reference Letter will be invited for an interview.

Interviews will be held from March 16 – March 27 in Toronto. Information about the interview format, date, time and location will be included with the invitation to interview that will be emailed to selected applicants.

#### **Selection Process**

The selection process is a four step process.

Step One – mid February

Applications assessed to determine if applicants have met the minimum academic admission requirements. For those who meet the minimum academic admission requirements their Personal Statement and Reference Letter are reviewed and scored at this time.

Step Two – end of February

Invitations to interview are emailed to selected applicants.

Step Three – March 16 – March 27

Personal interviews are conducted in Toronto.

Step Four – April

Offers of Admission are sent to selected successful applicants. All other applicants are notified of the status of their application decision.
