Proposed Policy:

Access & Equity Admissions Policy

Nipissing University welcomes applications from persons of diverse backgrounds. We recognize that there are institutional processes and cultural differences that present barriers to some applicants obtaining access to university. Nipissing University is committed to diversity, equity and accessibility and have reserved spaces in our undergraduate programs for students from groups including but not limited to, Indigenous people, persons with disabilities, economically disadvantaged, Franco-Ontarians, visible minorities, LGBTQ+ and those from northern/remote/rural areas.

To be considered you must:

- apply to year one of an undergraduate program (application to be submitted through OUAC)
- have completed the minimum prerequisite courses for admission
- submit a letter to the Admissions Office outlining your barriers and how you plan to be successful at Nipissing University.

Students admitted under this policy are required to meet the university and program standards for progression and graduation.

Current Policy:

Accessibility Admissions

59.0 NIPISSING UNIVERSITY ACCESSIBILITY ADMISSIONS POLICY

Each year Nipissing University makes available a number of spaces for accessibility admissions of Canadian citizens and landed immigrants, who apply to the year one undergraduate program from high school or community college, or to the one year teacher education program. This is to give special consideration to individuals from specified groups.

Year one undergraduate applicants who have achieved the minimum acceptable average for admission to the University, but whose academic record does not include the higher average required for their chosen program, may apply for consideration as a special applicant under the categories listed below.

Teacher education applicants who have met the minimum admission requirements, completion of a bachelor's degree acceptable to Nipissing University, but do not meet the higher admission standard established for the given year, will be granted similar consideration.

At the time of their initial application, applicants requesting special consideration must submit evidence to document their entitlement to be considered under one or more of the following categories:

- the applicant is of Aboriginal ancestry
- the applicant is a member of a visible minority, or
- the applicant is differently abled

Applications are reviewed on an individual basis and interviews may be required. The committee may restrict the number of courses for which an applicant may register.

Students admitted under this policy are required to meet the same standards for progression and graduation as required of all other students.

This policy will be reviewed by the Senate Committee on Admissions, Promotions and Petitions every three years, and more frequently if necessary. The results of such reviews will be presented to Senate.

NIPISSING UNIVERSITY ACCESSIBILITY ADMISSIONS PROCEDURES

1. The selections of applicants under the categories of:

- the applicant is of Aboriginal ancestry
- the applicant is a member of a visible minority
- the applicant is differently abled

Will be determined by faculty committees established by the Dean of each faculty and including one faculty member from the other faculty. These committees will be responsible for establishing their own procedures and implementation schedule. The committee's decisions will be final (i.e., applicants may not appeal the decision to the Senate Committee on Admissions, Petitions and Promotions).

REPORTS FROM OTHER BODIES

The President acknowledged the death of one of our students, Shelby Dickey, a student and part of our Lakers community. Ms. Dickey passed away in a tragic cycling accident. She was four days away from defending her Master's thesis and earning her Master of Science in Kinesiology. Upon recommendation of the Dean, the Senate Executive Committee, on behalf of Senate, approved to confer the posthumous Master of Science in Kinesiology degree. This request was expedited to the Senate Executive Committee so that the degree could be provided as quickly as possible to the student's family. As the degree will be presented to the family at the Memorial Service planned for September 15, the President requested that the Motion be presented to the Senate for approval.

The President began his report by welcoming new and returning Senators. He advised that over the summer months we did extraordinarily well with student applications and confirmations of attendance. Our Indigenous programs were well attended, and for the first time our residences are all full. He acknowledged the excellent work of the recruitment team and admissions' staff, and that the process will start all over again with the Ontario University Fair taking place at the end of the month. The President advised that as university sources of revenue have been capped, internationalization and philanthropy will be significant priorities for this year. Meetings have taken place with the government to discuss the offset of tuition by 10%, and we should hear within the next few weeks where we are on the scale.

The Provost and Vice-President Academic and Research provided a written report. The report is attached to the Minutes.

The Senate representative of the Board of Governors, Bobby Ray, welcomed the Board of Governors, new Senate representative, Stuart Kidd. He also advised of the recently held Board Retreat and the Joint Board Senate Orientation.

On behalf of the Alumni Advisory Board, Bridgette Perron, Alumni Relations Coordinator, provided a report. The report is attached to the Minutes.

OUESTION PERIOD

In response to a question regarding the Northern Grant, the President advised that grants have been provided to the four northern universities to offset costs due to living in the north. Each of the other universities receives about \$6M in funding and Nipissing University receives \$1.8M. The rate was set when we were a very small institution. Since June, two meetings have been held with our MPP, and letters have been written to the MTCU. The Minister is expected to be on campus next week, and a meeting and discussion of this matter is anticipated.

The Agenda of the October 1, 2019 By-Laws and Elections Committee meeting was approved. Dr. Tabachnick requested that the striking of an Ad Hoc Committee be added to the Agenda under New Business.

A discussion took place regarding the proposed amendments to the membership of Article 9.2, Academic Curriculum Committee, that were included in the September 13, 2019 Senate Agenda as a Notice of Motion. If a member of the Search Committee is absent for an interview of one of the candidates, she/he shall not participate in the voting or deliberation process as each voting committee member must be in a position to weigh the merits of each candidate prior to making a recommendation. However, if the search process involves other rounds of interviews and voting, the member may participate in the voting or deliberation for those subsequent rounds.

The addition of the proposed language would align the two policies. The Provost suggested the possibility of electing alternates on Search Committees. She advised that the Senate Policy document will be reviewed as per the Annual Academic Plan. The first steps will be to determine who the policies are operational to and when they were last updated. Changes will be discussed at the By-Laws and Elections Committee meetings.
