The President stated that Senate has identified that there is a problem with the Board policy, and suggested that the vote be postponed, and he will request that the Board review the policy and render a vote as soon as possible.

Senator Winters requested that the above motion be withdrawn. The seconder of the motion, Senator Srigley, also agreed to withdraw the motion.

President's Senate Report – July 8, 2022

The President noted that orientation activities have been happening on campus for the past few days. Many Faculty members have been engaging in research at this time; if you would like your research findings or achievements promoted on social media, please advise the President's office.

We recently held Convocation for the graduating class of 2022. Our classes of 2020 and 2021 were very appreciative of being able to attend Convocation in person. Many thanks to our staff members, particularly Maggie and Abby and our teams of staff and volunteers and thank you to the Faculty members who attended the ceremonies.

We recently accepted a generous \$1M donation from the George and Helen Vari Foundation. We will be using \$750,000 for our new simulation labs in Nursing and \$250,000 for BIPOC scholarships. We will be looking to match these funds in the near future.

Colleagues will know that we have been engaged in an audit with the Auditor General's office over the past several weeks. Thanks to our staff members for all of their work. Do not be alarmed by the letter contacting you; the AG office insisted that we not alert you to the letter beforehand or coach any responses to questions.

Today we will elect Faculty members to two important hiring committees. The process which led to these changes was one of extensive consultation and receiving advice from the outgoing Dean of Research and Graduate Studies. The Provost's position will only change in title and not in responsibility. The new AVP Research, Innovation, and Graduate Studies emerged from faculty member feedback to enhance the profile and support of research at the university. Following broad consultation, the President made these changes, and the Board received the items for information.

A meeting of the Senate Executive Committee took place by Zoom conference on September 1, 2022.

The purpose of the meeting was to set the agenda for the September 9, 2022 Senate meeting.

A discussion took place regarding how future Senate meetings will be held this academic year. Members agreed that starting with the September 9 meeting, all Senate meetings be held inperson with an option to attend by Zoom conference. The Senate Secretary advised that meeting room F210 has been reserved and that room capacity and technology will be confirmed.

Members discussed practices to streamline Senate meetings for efficiency with the purpose of advancing university business. The President will provide written reports at the beginning of the term and at year-end. The Provost, as the highest academic officer of the university, will provide written reports in advance of each Senate meeting to be included in the Senate agenda. A request will be made that all reports under Reports From Other Bodies be received as written reports to be included with each Senate agenda, and that oral reports will not be provided. This will provide Senators and faculty with an opportunity to review the reports and provide substantive questions four days in advance of the Senate meeting as per the Senate By-laws. This will also allow the opportunity to provide fulsome answers at Senate meetings during Question Period.

The Report of the Academic Quality Assurance and Planning Committee dated July 22, 2022, and the Annual Report of the Academic Quality Assurance and Planning Committee dated August 29, 2022 were provided to the Senate Executive for inclusion in the Senate agenda.

The Annual Report of the By-Laws and Elections Committee dated June 24, 2022 was provided to the Senate Executive for inclusion in the Senate agenda.

It was advised that an Academic Curriculum Committee meeting has been scheduled for September 2 to discuss a time-sensitive motion involving the introduction of a new Post-Baccalaureate. Should the motion be approved, an ACC Report will be provided to the Senate Secretary for inclusion in the Senate agenda under New Business.

The elections for a Deputy Speaker of Senate, faculty Senators to serve on the Board of Governors, faculty Senators to serve as the Council of Ontario Universities (COU) Academic Colleague and Alternate, and an A&S faculty Senator to serve on the Senate Executive Committee will be included in the September 9, 2022 Senate agenda.

The President advised that the Board of Governors Executive Committee met to discuss the request made at the July 8, 2022 Senate meeting regarding the nomination and election process to include an Indigenous Scholar on the committee for the Search/Appointment/Reappointment of the Associate Vice-President Research. It was noted that the title of this position has changed from Associate Vice-President Research to Associate Vice-President Research, Innovation, and Graduate Studies.

The President advised that the Executive Committee, on behalf of the Board of Governors, approved a one-time exception to section E. 3. e) Composition of Search Committees – Associate or Assistant Vice-Presidents within the Search/Appointment/Reappointment of Senior Academic Administrative Officers Policy to allow for a non-tenured faculty representative on the committee. The principle of the motion is to allow for a non-tenured Indigenous Scholar to be elected to the Search Committee.

A concern was expressed that vacant Senate positions are very slow being filled. The Senate Speaker advised that he will be unable to attend the October 14 Senate meeting due to a prior commitment, and to date no nominations for the Deputy Speaker of Senate have been received. It was noted that the number of Senate committees could be a concern. Possible solutions will be discussed at future By-laws and Elections Committee meetings.

The NUSU VP Advocacy and Awareness requested that NUSU students be permitted to participate in Senate and Senate committee meetings remotely. Members agreed that as Senators participate in meetings remotely, to be inclusive, that students also be permitted to attend meetings remotely.

Review and Approve the Stage II New Program Proposal – BA in Environmental Studies (Honours Specialization; Specialization; Major)

The Stage II New Program Proposal - BA in Environmental Studies (Honours Specialization; Specialization; Major) was reviewed. Dr. James Abbott provided a brief summary, advising that the proposal is a product of the hard work done by Dr. April James and the ad hoc working group. There was also substantial input from the Dean's office, Institutional Planning, Finance, Library, RO, and the Graduate Environmental Studies steering committee. This program builds upon the multi-disciplinary linkages between disciplines and integrates the undergraduate and graduate programs using our existing resources. It complements the Environmental Sciences program, and it brings together both the Environmental Science and Environmental Studies programs. There is also an experiential learning aspect with existing courses.

Once the final report is received from the external reviewers, the comments will be discussed at AQAPC, approved, and forwarded on to Senate.

Description of the Proposed Program

Provide a description of the program, clearly stating the purpose, structure and pedagogical rationale, including an explanation of the proposed degree nomenclature.

The proposed Post-Baccalaureate Diploma in Health and Social Impact is specifically geared to international students who wish to obtain additional qualifications enabling them to gain valuable experience within the field of global health; local, regional, and international settings. This diploma is holistic, trans-disciplinary and interdisciplinary in its approach to health studies, which is vital to understanding the many factors that impact health, healthcare, and health services. It reflects the unique characteristics of sustainable health service provision in Canada, with special attention to urban, northern and rural health, and across the world, and will enable students who are interested in health-related careers to gain important perspectives on health issues in these regions. Topics will include, but are not limited to: social determinants of health and wellbeing; environmental health and healthcare; Indigenous health issues and approaches; globalization and health impacts; implementation science, program evaluation, and policy; health systems lifespan; population health.

The relevance of interdisciplinary and holistic approaches to health and health education is particularly salient at this time; the covid-19 pandemic and the emerging impacts of climate change demonstrate just how interconnected we are globally and across geographic regions and ecosystems. The importance of a broad and diverse knowledge base is vital in many regions where health workers must provide multiple types of care due to a lack of resources (Buregyeya et al., 2021; Dalton et al., 2003). This may be due to geographic distance and rurality, a lack of funding options, and so on. The field of health and healthcare relies on professionals from a wide range of disciplines to provide quality healthcare to individuals, families and communities. Not all are nurses or physicians. The rationale for this program aligns with the importance of engaging a variety of skills that will contribute to building robust and sustainable healthcare services. Holistic and interdisciplinary education brings various knowledge bases and skills together that combine to enhance healthcare education and research, ultimately strengthening the health and wellbeing of communities, families and individuals (Cooper, Carlisle, Gibbs & Watkins 2001; Ghimouz, O'Sullivan, Baltatu & Campos 2021). The students in this program will be arriving with a variety of disciplines and from diverse cultures, further supporting the need for interdisciplinary learning and

research. In turn, their learning will encourage enhancing holistic interdisciplinary health programming for future students.

Nipissing University already possesses strengths in inter-disciplinary course and program offerings that are unique. The faculty expertise and research strengths, as evidenced in successful grant applications and publications, will ensure the success of the diploma and the students. The university has also signed onto the Rural and Northern Immigration Pilot Program in response to the government's priority on northern health issues. The courses offered through this diploma will enable students to draw connections between health and diverse disciplines. These courses already exist, so no additional resources will be required.

Explain how the proposed program fits with the University's strategic plan

The 2015-2020 Strategic Plan includes a strong commitment to providing international students with a personalized learning experience. The proposed Post-Baccalaureate Diploma in Health and Social Impact will provide students with new holistic interdisciplinary opportunities to explore health, expanding their knowledge and experiences within a small, vibrant, and individualized university environment.

In addition to supporting holistic and interdisciplinary health education within the university, this diploma is an opportunity to explore further needs in this area of programming to identify future strategic investment in new and expanded under- and postgraduate programming at Nipissing University.

Details of Resource Implications

The requirements of the proposed Post-Baccalaureate Diploma can be met by the current resources at Nipissing University.

Human Resources: Program design is based on existing courses.

Physical: Any increases in physical resources requirements would be aligned with generating new enrollments.

Budgetary: This program will innovate based on existing human and physical resources.

Evidence of Consultation with Affected Academic Units

This proposal was jointly prepared by faculty members within the Faculty of Arts and Sciences (: Departments of Child & Family Studies, Psychology, Geography, Indigenous Studies, Political Science, Sociology and Anthropology, Social Welfare and Social Development). Consultation with Education and Professional Studies units will continue. The main issues with EPS courses are prerequisites, and capacity issues. We will continue to consult with EPS to identify courses that can contribute to the Health and Social Impact Diploma.

Evidence of Consultation Regarding Space Needs for the Proposed Program Include the results of any consultation with Facilities regarding the space needs of the proposed program.

Any changes in physical space requirements would be aligned with generating new enrollments.

Evidence of Student Demand (including projected enrollments, limits, etc.)

Projected enrollment is expected to be up to 50 international students, based on discussions with the International Student Recruitment Liaison.

Evidence of Societal Need

In surveying the current range of health studies programs at universities across Ontario, it is clear that there is a need for health programs that are not focused only on medical or nursing school preparation. Administration, data and information flow, allied health services such as patient education, and so on, are one example of increasing need. Healthcare settings in northern and rural areas offer opportunities to fully explore the myriad intersections of academic disciplines, along with experiential learning opportunities, that will enable students to graduate with a solid and broad base of knowledge. This will enable them to adapt to diverse and shifting environments in their future learning and work pathways.

Duplicative Similarities

Provide evidence that any duplicative similarities to existing programs – internally, provincially or nationally – are justifiable for reasons of public funding.

There are no current internal duplicates of this program. A holistic inter-disciplinary Health Studies program is in development, but this will be a full undergraduate program, and not targeting post-baccalaureate students.

Across Ontario, universities are offering various types of undergraduate and graduate health studies programs. For example, Laurentian offers a graduate program in interdisciplinary Health Studies, but with a narrow focus on methodology and health of the Canadian population. The University of Windsor offers a full undergraduate program in interdisciplinary health sciences, emphasizing the sciences across the courses offered. York University offers full 4-year program in Health Studies, with an emphasis on policy, management and informatics. McMaster University offers full undergraduate programs in Health Studies, as well as a 1-2 year masters in health and aging. Wilfred Laurier offers a Community Health BA at the Brantford campus that includes an option to obtain an additional certificate within the program in Autism and Behavioural Science, or in Mental Health and Substance Use, in partnership with Conestoga College. Despite the proliferation of health studies, none appear to be offering a post-undergraduate diploma that enable international students to gain valuable learning opportunities and experience, including northern, rural, and indigenous health considerations.

Decanal Comments

Include certification from the relevant Dean(s) that the new degree/major is an appropriate and desirable addition to the academic programs of the University, and that a proposed discontinuation is appropriate and in line with the strategic direction of the Faculty. As well, a clear commitment that the new program will be appropriately resourced. For undergraduate programs, the relevant Dean(s) shall be the Dean(s) of the Faculty within which the program resides. For graduate programs, the appropriate Deans shall be both the Dean of Graduate Studies and the Dean(s) of the relevant Faculty or Faculties.

This is a timely proposal. I fully support this initiative. The Post-Baccalaureate Diploma in Heath and Social Impact presents an opportunity to expand AS offerings on existing resources and courses. It will also contribute to revenue generation.
